Surface Preparations and Finishing

Before using the Zwaluw B&B Primer Universal refer to the Health & Safety Sheet. All surfaces must be clean, dry and free of dust, grease and other loose material. Thoroughly clean by using a Zwaluw Cleaner and two cloths. Contact our Centre of Excellence for a full recommendation. Clean brush immediately with Zwaluw Cleaner. Clean hands with Zwaluw Wipes. Apply Zwaluw B&B Primer Universal with a paint brush. Apply a thin and even film.

Cleaning

Uncured material and tools can be cleaned by using Zwaluw Cleaner. Cured material can only be mechanically removed. Hands can be cleaned with Zwaluw Wipes.
